Jan	FEMALE IP STATES WHILST ATTENDING NIGHTCLUB SHE HAD BE IN AND OUT THE BAR NUMEROUS TIMES PUSHING PAST THE BOUNCERS; CLAIMS BOUNCER HAS TOUCHED HER BREST ON TOP OF HER CLOTHING BY A CUPPING MOVEMENT	Victim declines or is unable to identify suspect
Jan	KNOWN MALE EJECTED BY DOORSTAFF ASSAULTS DOORMAN AFTER ALTERCATION WITH NO INJURY CAUSED	Evidential Difficulties
Jan	AFTER BEING EJECTED FROM NIGHTCLUB; DOORMAN LUNGES TOWARDS IP TO INTENTIONALLY KNOCK OUT MOBILE PHONE FROM HIS HAND INTENDING TO CAUSE DAMAGE	Victim does not support police action
Feb	IP IS IN CLUB AND ASSAULTS DOORSTAFF. DOORSTAFF DETAIN MALE	Victim does not support police action
Feb	IP WHO IS A DOORMAN EJECTS MALE FROM PUBLIC HOUSE BECAUSE OF HIS DRUNKEN BEHAVIOUR. MALE THEN SPITS AT THE IP	Victim does not support police action
Feb	IP IS A DOORMAN AND HAS EJECTED THE SUSPECT FROM THE PREMISES. AT THIS POINT THE OFFENDER HAS THREATENED TO STAB HIM WITH A KNIFE.	Victim does not support police action

Feb	UNKNOWN MALE THREATENS TO BOTTLE VICTIM WHILST WORKING AS A DOORMAN.	Victim does not support police action
Mar	UNKNOWN MALE ENTERS BAR AND APPROACHES BAR SAYING 'THE BOUNCER IS IN FOR IT' BEFORE LEAVING	Victim declines or is unable to identify suspect
Mar	UNKNOWN MALES ARE TOLD TO LEAVE BAR BY DOORSTAFF. MALES ARGUE WITH DOORSTAFF. ONE OF THE MALES PUNCHES DOORMAN IN HEAD. MALE LEAVES AREA.	Evidential Difficulties
Mar	IP JUMPS ONTO THE STAGE OF CLUB AND IS ALLEGEDLY ASSAULTED BY BEING PUNCHED ONCE BY THE BOUNCER PRIOR TO BEING ESCORTED OUT OF THE PREMISES.	Investigation Complete - No suspect identified
Mar	WHILST ON DUTY, DOORMAN EJECTS MALES FOR FIGHTING IN T OILETS; OUTSIDE ONE OF THE EJECTED MALES SHOUTS ABUSE THEN MAKES OFF FROM AREA.	Victim declines or is unable to identify suspect
Mar	MALE LEAVES BAR AND ON LEAVING IS HELD TIGHTLY AROUND HIS ARMS AND PUSHED BY THE DOORMAN IN WHICH HE BELIEVES IS AN UNPROVOKED ASSAULT	Victim declines or is unable to identify suspect
Mar	UNKNOWN OFFENDERS ASSAULT DOORMAN BY BITING HIS SHOULDER AND STRIKING HIS ARMS	Victim does not support police action
Mar	UK MALE BOUNCER SHOUTS AT IP; PUTS HIM IN A HEADLOCK AND DRAGS HIM FROM SMOKING AREA INTO BAR. ASSUALTS HIM BY PUCHING TO THE HEAD SEVERAL TIMES. BOUNCER THEN THROWS IP OUT ON THE STREET.	Investigation Complete - No suspect identified
Mar	MALES STATES HE WAS SAT IN AN AREA OF A BAR AND WAS ASKED TO MOVE BUT WITHOUT EXPLANATION AND SO QUESTIONED THIS REQUEST. THE DOORMAN THEN DRAGGED HIM OUT WITH HIS ARM AROUND HIS NECK WITHOUT FURTHER WARNING CAUSING NO INJURY.	Investigation Complete - No suspect identified
Mar	UNKNOWN MALE (BOUNCER) HAS PUSHED CALLER OUTSIDE THE BAR CAUSING MARKS/INJURY TO ARM	Investigation Complete - No suspect identified
Apr	KNOWN FEMALE FOLLOWING LAWFUL EJECTION FROM BAR BY DOORSTAFF BECOMES AGGRESSIVE AND ASSAULTS DOORMAN BY PUNCHING TO THE FACE.	Victim does not support police action
Apr	IP REMOVES DOORMAN'S HAT. DOORMAN THEN GRABS IP AND THROWS HER TO THE GROUND CAUSING SORENESS TO HER FACE	Investigation Complete - No suspect identified
Apr	IP IS ASSAULTED BY BOUNCER WITHIN NIGHTCLUB BY BEING PUNCHED TO THE FACE AND HEAD A NUMBER OF TIMES.	Not Stated
Apr	KNOWN PERSON TAKEN LANTARD CONTAINING TILL KEY FROM AROUND THE IPS NECK BEFORE HITTING HER OVER THE HEAD WITH IT AND GRABBING AT HER HEAD. ASSAULT WAS STOPPED BY BOUNCERS AT THE ENTRANCE OF THE PUB. OFFENDER MAKES OFF PRIOR TO POLICE ARRIVAL.	Victim does not support police action
Apr	KNOWN MALE SEEN TO BE IN POSSESSION OF DRUGS BY DOORMAN. DETAINED AND SEARCHED BY DOORMAN WHERE HE HAD SEVERAL BAGS OF AMPHETAMINE	Caution adult
Apr	IP PART OF GROUP EJECTED FROM PUBLIC HOUSE. DURING SO IP IS SLAPPED IN FACE BY DOORMAN.	Evidential Difficulties
Apr	IP IS EJECTED BY BOUNCERS AND AND CAN'T REMEMBER ANYTHING ELSE UNTIL HE WAKES UP ON THE PAVEMENT WITH A BLOODY NOSE.	Investigation Complete - No suspect identified
Apr	FOLLOWING IP BEING REFUSED ENTRY TO BAR; DOORMAN KICKS IP'S PHONE FROM IP'S HAND CAUSING DAMAGE TO PHONE. IP LEAVES SCENE	Investigation Complete - No suspect identified
