| Jul-16 | Central | BOUNCER AT PUBLIC HOUSE PUSH IP IN THROAT AS HE WAS TRYING TO GET BACK IN THE CLUB | Victim declines or is unable to identify suspect |
| Sep-16 | Central | DOOR STAFF GRAB IP BY THE THROAT THROW HIM OUT THE BACK DOOR CAUSING GRAZE TO ARM | Investigation Complete - No suspect identified |
| Sep-16 | Central | BOUNCER EJECTS IP FROM BAR BY GRABBING IP BY THROAT IP BELIEVES HIMSELF TO BE A VICTIM OF ASSAULT | Victim declines or is unable to identify suspect |
| Oct-16 | Central | BOUNCER PUNCHES IP WITH LEFT HAND TO RIGHT SIDE OF HEAD CAUSING REDNESS; SHOUTS 'GET BACK' AND PUNCHES IP IN SAME PLACE AGAIN. | Investigation Complete - No suspect identified |

| Apr-17 | Central | DOOR STAFF AT PREMISES ASSAULT TWO PEOPLE FOR NO REASON MAKING THE IP TO FEAR FOR THEIR SAFETY | Evidential Difficulties |
| Aug-17 | Sunderland Central | DOOR STAFF PUNCH MALE VICTIM IN THE FACE CAUSING A BLOODED MOUTH | Investigation Complete - No suspect identified |
| Oct-17 | Central | BOUNCER TRIES TO EJECT IP; WHILE DOING SO IP FALLS TO FLOOR AND BOUNCER APPROACHES AND KICKS IP IN HEAD. | Caution adult |
| Dec-17 | Central | DOOR STAFF OF PUBLIC HOUSE FORCIBLY REMOVE IP'S FRIEND FROM BAR. WHEN IP INTERJECTS; DOOR STAFF PUSH IP TO GROUND CAUSING FRACTURE INJURY. | Evidential Difficulties |

| Jan-18 | Central | BOUNCER GRABS IP BY SHOULDER BEFORE PUSHING HIM OUT THE BAR USING FORCE. | Investigation Complete - No suspect identified |
| Mar-18 | Central | DOOR STAFF INJURE IP AS SHE IS BEING EJECTED FROM CLUB. | Investigation Complete - No suspect identified |
| Mar-18 | Central | DOOR STAFF ASSAULT IP BY USING EXCESSIVE FORCE TO REMOVE HIM FROM THE PREMISES BY TWISTING FINGERS AND CAUSING HIM TO HIT HIS HEAD | Evidential Difficulties |
| Mar-18 | Sunderland Central | DOOR STAFF EJECT MALE FROM THE CLUB BY GRABBING MALES EAR AND LEADING HIM OUT THE MAIN DOORS. | Victim declines or is unable to identify suspect |
| Apr-18 | Central | DOOR STAFF HAVE REMOVED FROM NIGHTCLUB AND PUNCHED IP TO FACE CAUSING INJURY | Investigation Complete - No suspect identified |
| May-18 | Central | KNOWN MALES; AFTER VERBAL ALTERCATION PUNCH IP TO FACE CAUSING INJURY | Caution adult |
| Jun-18 | Blyth | BOUNCER PUNCHES VICTIM TO FACE AFTER HE HAS AN ALTERCATION WITH A FEMALE. | Victim declines or is unable to identify suspect |
| Jul-18 | Riverside & West | DOOR STAFF AND KNOWN MALES ASSAULT VICTIM BY PUNCHING AND CHOKING VICTIM DURING EJECTION FROM A PREMISES. | Victim does not support police action |
| Oct-18 | Ashington | DOOR STAFF REFUSE ENTRY TO VICTIM; DOOR STAFFS ACTION AMOUNT TO THAT OF COMMON ASSAULT. | Victim declines or is unable to identify suspect |
| Dec-18 | Central | DOOR STAFF EJECT FEMALE FOLLOWING A VERBAL DISPUTE; FEMALE BELIEVES EXCESSIVE FORCE TO HAVE BEEN USED. | Victim declines or is unable to identify suspect |
