UNKNOWN MALE SUSPECT CONTACTS VICTIM BY TELEPHONE AND THREATENS WITH A MACHETE CAUSING VICTIM TO FEEL DISTRESSED

GROUP MALE AND FEMALE YOUTHS APPROACH IP AND ARE VERBALLY ABUSIVE. 1 X MALE OFFENDER PUNCHES IP ONCE TO FACE CAUSING HIM TO FALL TO THE GROUND. OFFENDER THEN REMOVES ITEMS. OFFENDER THEN CHASES IP WHILST BRANDISHING A MACHETE CAUSING A SMALL CUT TO HIS LIP.

OFFENDER STRIKES VICTIM WITH MACHETE TO SCALP CAUSING 2" CUT; THEN STRIKES VICTIM'S FACE AND BODY USING WOODEN BAT CAUSING SUSPECTED BROKEN JAW AND BRUISING.

KNOWN MALE HAS ATTACKED IP IN STREET AFTER A VERBAL ARGUMENT. IP STATES MALE USED A MACHETE AND MEAT CLEVER DURING ASSAULT.

MEMBER OF PUBLIC BELIEVES SHE SEES U/K PERSON IN PUBLIC PLACE WITH A MACHETE OR SIMILAR

UNKNOWN MALES APPROACH IP DEMANDING THE RETURN OF SOME OUTSTANDING CONTROLLED SUBSTANCES; IP HAS BEEN KNOCKED TO THE GROUND WHERE HE HAS BEEN KICKED REPEATEDLY AND HAD A NOXIOUS SUBSTANCE SPRAYED ONTO HIS BACK

IP IS APPROACHED BY TWO OTHER YOUTHS WHO MAKE THREATS TO HARM THE IP BY THROWING ACID AT HIM.

VICTIM IS IN STREET OUTSIDE OF HER ADDRESS WHEN OFFENDER SHOUTS TO VICTIM 'I'LL GET SOMEONE TO SORT YOU OUT'. VICTIM THEN HEARS OFFENDER MUMBLE SOMETHING UNDER HIS BREATH ABOUT ACID.

IP RECEIVES EMAIL FROM U/K PERSON MAKING DEMAND TO PAY TO AN ANONYMOUS BITCOIN WALLET OR HAVE ACID THROWN ON HIM.

PERPETRATOR HAS THREATENED TO RUN HER DOWN; TASER HER & THROW ACID IN HER FACE
